Good afternoon,

As many of you know, we opened our phone lines and online scheduler at 8:30 a.m. on Tuesday morning so that eligible individuals could make an appointment for their first and second dose of the COVID-19 vaccine. If you called or visited our website, you may also know that it was extremely difficult to connect due to the overwhelming volume of people who tried to make an appointment. In fact, there were 155,000 attempts to reach our appointment schedulers within the first half hour and more than 2.7 million hits on our website servers. Although it was frustrating for most, I am pleased to say that we were able to book nearly 4,000 appointments within a few hours and that we are also making it possible for those that make their first appointment to also make their second.

I must stress that demand for the vaccine continues to outpace supply. However, our vaccination site has been operating very efficiently and has the capacity to serve more than double our current volumes. As we continue to request more doses, I ask that you remain patient while we explore new ways to distribute vaccines to the community.

#### **Important Things to Know**

• The application process is open for the Michigan Small Business Survival Grant Program. Macomb County has received \$4.1 million from the state to assist businesses that have experienced significant financial hardship due to the COVID-19 emergency orders issued by MDHHS in November and December 2020.
