Important Things to Know

Everyone aged 16* and up in Michigan is now eligible to receive a COVID-19 vaccine. <u>Schedule your appointment today</u> at one of Macomb County's vaccine clinics. **New appointments are added daily and available now**. Please check the scheduler to book your slot as soon as possible. *Note: Only the Pfizer vaccine has been approved for individuals aged 16 and 17. Individuals in this age group must make an appointment at the Verkuilen Building only and must be accompanied by a parent or guardian.*

Already received your COVID-19 vaccine? Check in with your family, friends and neighbors to help them through the process. Maybe they have questions about how and where to schedule an appointment. Or perhaps they want more information about the vaccine. Let them know that they can easily find all of that detail by visiting <u>macombgov.org</u>. We can reach herd immunity and put the pandemic behind us, but we need to get more people vaccinated first. Help us reach that goal by connecting with your network.

The Macomb County Health Department has received calls and information indicating that some sources have been telling people who have had COVID-19 that they need to wait 90 days until they receive a COVID-19 vaccination. To clarify – most people who have had COVID-19 can get a vaccination after they have completed the 10-day isolation protocol and no longer have a fever. Individuals who received monoclonal antibody treatment for their COVID-19 infection have to wait 90 days prior to their vaccination.



The CDC and the U.S. Food and Drug Administration recently lifted the recommended pause on the Johnson & Johnson COVID-19 vaccine use following a thorough safety review. <u>Click here</u> to read their full statement.

A new report in CDC's MMWR is among the first to evaluate the benefits of mRNA COVID-19 vaccines (Pfizer-BioNTech, Moderna) against hospitalization in real-world conditions. People 65+ who were fully vaccinated were 94% less likely to be hospitalized with COVID-19 than people in the same age group who had not been vaccinated. People who were partially vaccinated (14 days after the first dose of a two-dose vaccine) were 64% less likely to be hospitalized. CDC recommends getting a COVID-19 vaccine as soon as you can to prevent serious illness from COVID-19. Learn more.
