

Thank you for your continued membership with the Grosse Pointe Board of REALTORS[®]. This email serves as your official notice of your 2022 dues renewal. Your dues invoice is now available for payment online and should be paid on or before January 14, 2022. **Please read this email carefully.**

MONTHLY BILLING OPTION: Primary REALTOR[®] members who wish to enroll in the Installment Payment Plan (IPP) for their 2022 dues renewal must do so by 10/24/21. Please <u>click here</u> to access IPP (Installment Payment Program) enrollment information and related documents. Your broker must opt-in for you to participate.

HOW TO VIEW & PAY YOUR 2022 DUES INVOICE:

- Go to <u>www.GPBR.com</u>
- Click on **MEMBER PORTAL** at the top of the page
- Log in with your email and password
 - **Email:** use the email to which this notice was sent
 - o Default Password: password123 (Unless you have already changed it)
 - Click **Sign In** button
- Once logged in to your dashboard, go to the **Account Balances** section on the right side of the screen and click the **Pay Now** button to view and pay your 2022 dues invoice.

IMPORTANT - DUES DEADLINE

The deadline for payment in full of 2022 dues is December 31, 2021. We have built in a grace period until January 14, 2022 to accommodate members that wish to pay in the 2022 calendar year. If dues are not received by January 14th, unpaid members will be subject to a \$25 late fee and suspension of member benefits including MLS access. Members who have not paid dues by January 31st will have their membership terminated. After termination, a re-instatement fee of \$50, *in addition to the late fee*, will be imposed for members wishing to re-join the board. **All dues are non-refundable**.
